As we reopen the lobbies, we want to make you aware of the additional safeguards we have in place and what you can do to help. Before visiting your local Members Choice Branch it is important to:

1. **Self-evaluate.** You make sure you are feeling well and not running a fever.
2. **Wear your mask.** Members will be required to wear a mask while visiting our lobbies.
3. **Practice social distancing.** We have added signage and floor indicators to make this easier for our members.
4. **Be Kind and Patient.** While we all continue to adapt to the guidelines that are in place there may be fewer windows available. Our team may also need additional time to clean and sanitize between transaction to ensure your safety.

Members Choice employees are practicing the following safeguards:

1. Members Choice employees are required to wear masks and follow best practices for social distancing.
2. Handwashing, and cleaning and disinfecting activities will occur hourly. This includes commonly touch surfaces like the atm, doors, drive-thru tubes, and counters.
3. Protective barriers have been installed at all our lobby windows.

While we are excited to once again welcome our members to the lobbies, we encourage you to continue to use online and mobile banking, as well as our drive-ups, mobile deposit, and the night depository whenever possible, unless entering the lobby is necessary to complete your transaction.
