If you exceed these limitations, your account may be subject to a fee or be closed.

²An Account is considered dormant after 1 year of inactivity. Minimum balance of \$25.00 required to avoid fee. Youth accounts will not be charged.

³Fees will be applied to transactions greater than \$10.00. Overdrafts must be paid within one week. A limit of seven (7) combined Courtesy Pay and/or Debit Card Overdraft Tolerance fees will be charged to your account per day.

⁴This Fee only applies to Business Accounts after 250 transaction have been processed in a statement cycle.
